ENDORSEMENT AFFECTING ALL CIVIL MATTERS RETURNABLE IN THE SUPERIOR COURT OF JUSTICE IN LONDON, ONTARIO WITH RETURN DATES FROM MARCH 17 THROUGH JULY 3, 2020

Unless specifically ordered otherwise, this endorsement shall apply to all civil matters currently scheduled in the Superior Court of Justice in London, Ontario (except matters in the Small Claims Court) during the period commencing on Tuesday, March 17 and ending on Friday, July 3, 2020.

All of the matters referred to in the preceding paragraph are hereby adjourned as follows:

A. Civil Motions/Special Appointments

1. Special appointments returnable during the period commencing March 17 through July 3, 2020 are hereby adjourned to the July 10, 2020 motions court at 930 a.m. to be spoken to;
2. All other motions returnable during the period commencing March 17 through March 31, 2020 and previously adjourned until June 5 are hereby further adjourned to the July 17, 2020 motions court @ 930 a.m. to be spoken to;
3. All other motions returnable in April 2020 and previously adjourned until June 12, are hereby further adjourned to the July 24, 2020 motions court @ 930 a.m. to be spoken to;
4. All other motions returnable in May 2020 and previously adjourned until June 19 are hereby further adjourned to the July 24, 2020 motions court @ 930 a.m. to be spoken to;

5. All other motions returnable in June or on July 3, 2020 are hereby adjourned until the July 31, 2020 motions court @ 930 a.m. to be spoken to.

B. Civil Pre-Trials

1. Pre-trials scheduled for the period commencing March 17 through 31, April and May 2020 and previously adjourned until June 19 are hereby further adjourned to the July 17, 2020 civil assignment court @ 9 a.m. to be spoken to;
2. Pre-trials scheduled for June 2020 are hereby adjourned to the July 17, 2020 civil assignment court @ 9 a.m. to be spoken to;
3. At that time, the ability of the court and the parties to maintain the currently scheduled trial date will also be assessed.

C. Civil Trials (jury and non-jury)
