ChatGPT PROMPTING

ChatGPT PROMPTING

Give me a 1,500-word report that documents and explains the physical job demands, duties, responsibilities, and work conditions of a unionized cardiac surgical nurse working in Ontario.

ChatGPT PROMPTING

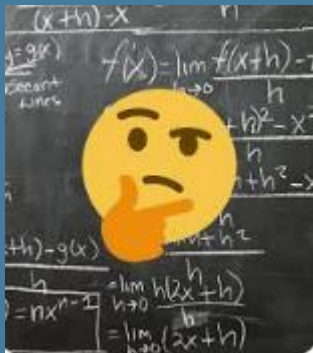
For this inquiry, speak to me as a radiologist who specializes in women's health and treat me as a radiology resident. How accurately do MRI scans detect soft tissue abnormalities, for such things as a pelvic floor hernia; adhesions of the bladder, uterus, intestines, and abdominal cavity; endometriosis. What does it show that is not detected on a trans vaginal ultrasound?

ChatGPT PROMPTING

A tenant in rented accommodations has a pet boa constrictor which exceeds two feet in length. It has escaped and cannot be located. The property has a lower unit and in the lower unit that family has a baby. Due to a medical crisis, the owner of the boa constrictor must move into supportive housing. Outline all the strategies that should be employed to locate the missing boa constrictor and any other recommendations for best practices in this situation. ChatGPT PROMPTING

MICROSOFT COPILOT PROMPTS
