National Judicial Institute - Model Criminal Jury Instructions

The National Judicial Institute is an independent institution that is committed to building better justice through leadership in the education of judges in Canada and internationally. It is overseen by a board of governors, chaired by the Right Honourable Richard Wagner, P.C., Chief Justice of Canada, and its board has judicial representatives from across Canada.

We recently found out about the comprehensive set of model criminal jury instructions, created by the Canadian Judicial Council's (CJC) National Committee on Jury Instructions, available at no charge on the National Judicial Institute's site. As stated on the introductory page, these jury instructions provide judges with standard language which they may use when speaking with members of

juries about their duties, the nature of the criminal charge before the court, and the legal rules which apply to the jury's deliberations. The model jury instructions can be downloaded in both Word and PDF formats.

LSO Library Catalogue and CPD Portal

The Great Library at the Law Society of Ontario has converted its former InfoLocate catalogue of resources to a new platform, the LSO Great Library and Ontario Courthouse Libraries Catalogue. This is how you can search what we have in our collection here

and to also see what is available at the other county and district law association libraries and the Great Library at Osgoode Hall. Better yet, you can do it from the comfort of your home or office and then email us to request we put aside items for you. If we don't have a resource with your answer in it here, we can request a scan from another library's resource or even borrow the item itself.

The LSO's former AccessCLE collection of its CPD papers going back to 2004 has also moved to a new platform: LSO CPD Materials. The benefit of this portal is that, while a search in the library catalogue will find papers and texts with your search terms in their titles, this site locates your terms in the papers themselves. This is a great way to start your research for information as LSO CPD papers will capture recent changes in the area of law.

All this information is available to you at no charge from your office at any time. Let us know if you need help finding information on either of these sites.

The MLA recognizes its members with five awards: Distinguished Service, Access to Justice, Rising Star, Philanthropy, and Distinguished Paralegal.

The MLA Awards

Award for Distinguished Service,

which recognizes exceptional career contributions and/or achievements by MLA members to the legal profession and/or a law-related benefit to the community including mentorship related to the profession of law and/ or leadership roles in the community. Those who will receive the award will have made a significant contribution to the profession of law, whether as a solicitor in effectively performing services in that position, as a barrister in attaining an excellent reputation in the courts, as an academic, or for a single act of notable distinction and/ or innovation in the practice of law that advances the ideals of the profession.

Award for Access to Justice, which recognizes individuals who have demonstrated a commitment to providing commendable legal services to those in need through Legal Aid Ontario or through pro bono legal

services and/or offered academic contributions pertaining to the study of legal aid and/or created innovative measures or built links between lawyers and community organizations/ advocates to promote better access to justice in Middlesex County.

Rising Star Award, which recognizes individuals who have distinguished themselves in the practice of law, who advances the ideals of the profession, demonstrating community involvement, and have been practicing for less than 10 years.

Award for Philanthropy, which recognizes exceptional contributions and/or dedication by MLA members to the community by supporting not-forprofit organizations and/or performing charitable services.

Award for Distinguished Paralegal

recognizes a paralegal's exceptional career contributions and/or achievements to the paralegal profession and/or a law-related benefit to the community including mentorship related to the paralegal profession and/or leadership roles in the community. 2025 MLA Awardees



What does receiving this award from the Middlesex Law Association mean to you?

It means a lot to me. I'm from London originally but moved away for law school and work after graduation. Coming back home was a decision I put a lot of thought into, and this award feels like a great validation of the choice I made. I'm very grateful to the Middlesex Law Association for this award and proud of the work that I'm doing in London.

2. What part of your work or contribution are you most proud of?

I am most proud of the positive impact I have had on people's lives. Most of my work involves representing individuals at the worst time of their career. Whether they are facing a regulatory complaint or investigation, a workplace investigation, or the loss of their job, my clients are often experiencing very high levels of stress. Being able to provide compassionate, understanding legal advice is incredibly rewarding.

3. How has the legal profession changed since you began your career?

I first started practising in London in March 2019, so I had about a year of practice under my belt before the pandemic turned things upside down. The biggest changes I've seen so far are related to technology. We now make virtual court appearances and use an electronic case management

system and artificial intelligence. These developments are exciting, but they also bring new challenges.

4. What advice would you give to young lawyers or law students starting out today?

When I work with law students, I find many are uncertain where they want to end up in their career. Like them, when I was in law school, I had no idea what area of law I wanted to practise. I assure them that there's no rush to figure it all out, and that it's okay to change your mind. I have had colleagues who left Bay Street (or Wall Street) law firms to practise criminal defence. I also encourage

them to consider what the life of a lawyer practising in that area looks like. Do you like working with people? On teams? Going to court? Sitting alone in your office drafting? Different areas of law look vastly different in terms of the day-to-day reality.

5. How do you see your work making a difference for clients or the community?

The work that we do as lawyers is fundamentally about serving people and organizations in our community. Of course, we know that it is easier for some to access legal services in our community than others. I have tried to make pro bono work a significant part of my practice and consider it a real benefit for the broader community. For young lawyers, there are many great ways to get involved, and I would encourage everyone to explore

the opportunities available with Pro Bono Ontario or another similar organization.

6. Who has been a key mentor or influence in your career?

I have had the benefit of many great mentors during my career. I was lucky enough to clerk for four judges - Chief Justice Strathy and Justices Feldman and Blair of the Court of Appeal and Justice Karakatsanis of the Supreme Court. They were all wonderful mentors and examples to me. I will always remember Chief Justice Strathy's willingness to roll up his sleeves at Lawyers Feed the Hungry and serve meals to some of the most vulnerable members of society. I'm also grateful to my mentors at Lerners. I have benefited greatly from working with senior lawyers such as Yola Ventresca and Carolyn Brandow, but I am also very grateful to my peers and mentees who have taught me so much.

7. What excites you most about the future of the legal profession?

There are lots of developments that excite me about the future of the legal profession. I expect that changes to the Rules of Civil Procedure and the increasing use of artificial intelligence will help improve access to justice. I also think that we, as lawyers, are more focused than ever on our obligation to society and, in particular, our role in upholding the rule of law. It's inspiring to see many lawyers reflecting on this and what we can do to protect the integrity of Canada's justice system.





1. What does receiving this award from the Middlesex Law Association mean to you?

It is a sense of appreciation toward the members who played a role in the nomination and selection process which caused me to reflect positively on some of the accomplishments of a long tenure in our profession.

2. What part of your work or contribution are you most proud of?

The growth of the Housing practice at the firm; the clients who form the backbone of the practice; and the dedication and skill of the Licensees at Cohen Highley who have continued to excel in providing legal advice and service to those clients.

3. How has the legal profession changed since you began your career?

Technology has greatly improved how and when we interact with clients to provide advice, service and advocacy.

4. What advice would you give to young lawyers or law students starting out today?

Explore and pursue the work that interests you and focus on providing great service to the clients who retain you. Don't be afraid to change course when your gut tells you to or circumstances force you to.

5. How do you see your work making a difference for clients or the community?

Clients recognize that our service ethic supports the success of their operations and I think they feel they can trust and rely on us to provide good judgment, good advice and strong advocacy.

6. Who has been a key mentor or influence in your career?

There have been a few: Harris Cohen. Justice Killeen both now deceased but both of whom influenced my perception of how to best serve clients, the courts and the profession.

7. What excites you most about the future of the legal profession?

Anticipation of how the profession will evolve and adapt in the context of continuing challenges to the rule of law and a rules-based system of societal governance which is under attack by all forms of media and misinformation and by conflicting cultural imperatives ... observing how the profession will adapt to these challenges is most interesting to me.



What does receiving this award from the Middlesex Law Association mean to you?

It means a great deal to be recognized by my peers for service to the community. The practice of criminal defence can be all-consuming, and much of the community work happens behind the scenes. To have those efforts acknowledged is a reminder that the profession values service beyond the courtroom.

2. What part of your work or contribution are you most proud of?

I'm proud of helping to build bridges between the legal community and organizations that support people at their most vulnerable. Whether it's raising funds for supportive housing, working with the CMHA, or helping feed families through Lawyers Feed the Hungry, it's the impact on real lives that matters most.

3. How has the legal profession changed since you began your career?

Since I have started my career, I have gained more awareness now about mental health, equity, and the need for balance in our work. The profession has become more open to conversations that used to be taboo, which I think makes us stronger advocates and more sustainable as practitioners.

4. What advice would you give to young lawyers or law students starting out today?

Find your voice early. Don't try to mimic someone else's style or path. This is a profession built on resilience, integrity, and authenticity. Don't be afraid to ask for help; nobody succeeds alone.

5. How do you see your work making a difference for clients or the community?

In the courtroom, I fight for fairness. Outside of it, I try to help create conditions where people have access to dignity, housing, food, and mental health support. Both sides of that work are about giving people a chance to be heard and to rebuild.

6. Who has been a key mentor or influence in your career?

I've been fortunate to have many mentors who pushed me to think critically and fight hard but also to remember compassion and long-term reputation. Their examples showed me that being an excellent lawyer is inseparable from being a quality person.

7. What excites you most about the future of the legal profession?

I'm excited about the next generation. I see students and young lawyers who are bold, socially engaged, and unwilling to accept "that's how it's always been done." That energy is what will keep the profession relevant and responsive to the communities we serve.

Right to be Forgotten in Canada: Google & PIPEDA

decision by the Canadian Privacy Commissioner against Google says there is a limited right to be forgotten in Canada under the PIPEDA privacy law. The right to be forgotten is an express right in the EU GDPR, but PIPEDA does not mention the concept.

A right to be forgotten means that in some circumstances an individual can demand that certain older information about them be deleted or no longer made available to the public.

Online reputation

This Google privacy investigation started with a complaint to the commissioner in 2017. The individual had been charged with a criminal offence regarding failure to disclose HIV status. The Crown stayed the proceedings soon after the charge was laid because they didn't believe the charge was appropriate.

The matter was reported in the press, and of course a Google search against the individual turns up these articles. The complainant felt those articles were "... outdated and misleading, and that because these articles are linked to their name in search results, the Complainant has experienced serious harms such as physical assault, lost employment opportunities, and severe social stigma."

Google de-listing Canada

The complainant wanted Google to delist these articles from a Google search. If that happened the articles would still be available on the publisher's websites, but a Google search against this name would not show them. Google refused to de-list them.

Google does de-list certain things, such as abusive content, and sensitive personal info such as banking and credit card information. But Google decided this situation did not fall under their delist policy.

After the investigation started Google took the position that it was exempt from PIPEDA. That issue was heard in the Federal Court, and the Federal Court of Appeal. They decided that Google was not exempt from PIPEDA.

The Commissioner released its findings in August 2025.

PIPEDA privacy

The Commissioner decided that in this circumstance the complainant's complaint was well founded, and Google should de-list the articles. Google has refused to de-list them despite the Commissioner's findings. Google questions whether PIPEDA actually includes this de-listing requirement.

So it sounds like we have not heard the end of this yet, and there is a good chance this will end up in court again.

Canadian privacy law

The Commissioner said "Individuals have the right, under Canadian privacy law, to have information about them de-listed from online searches for their name in certain circumstances when there is a significant risk of harm that outweighs the public interest in that information remaining accessible through such a search."

The decision listed these factors for the public interest test:

- a. Whether the individual is a public figure (e.g. a public office holder, a politician, a prominent business person, etc.);
- b. Whether the information relates to an individual's working or professional life as opposed to their private life;
- c. Whether the information relates to an adult as opposed to a minor;
- d. Whether the information relates to a criminal charge that has resulted in a conviction or where the charges were stayed due to delays in the criminal proceedings;
- e. Whether the information is accurate and up to date:
- f. Whether the ability to link the information with the individual is relevant and necessary to the public consideration of a matter under current controversy or debate;
- g. The length of time that has elapsed since the publication of the information and the request for de-listing.

If you are interested in a deep dive on this subject you can read the Commissioner's lengthy decision. Although this may not be the last word on the subject if it gets in front of the courts again.


Overview

Recent Practice Direction

n August 2025, the Superior Court of Justice for the Southwest Region (i.e. Southwest Ontario) published a useful practice direction regarding confirmation forms for civil and family proceedings. Specifically, the court seeks detailed confirmation forms to assist the justices determining those matters. Paragraphs 29 to 31 of the notice provides specific examples.

This practice direction is both a good reminder for senior counsel and a useful roadmap for junior counsel who often wonder what can properly be included in a confirmation form.

My takeaway is that a detailed confirmation is a good tool to strengthen one's position on the underlying court event (e.g. a motion)

through organization. This is akin to how a compendium, which is an organizational tool, can be used by counsel to make their submissions more persuasive. It seems the court will be fine with however the confirmation form is used so long as the practice is fair and it helps the court prepare for the matter.

This aligns with the general principle that a litigator should do what they can to make the court's job easier because it increases their odds of success

As of Right: A Discussion on the New Interprovincial Labour Reforms

his Labour Day, the Ontario government announced the historic implementation of "as of right" rules regarding Canadians' ability to work interprovincially. The Law Society's CEO welcomed the announcement, noting the societies long standing support of removing provincial barriers for lawyers to improve professional development and client services.

First introduced under the *Protect*Ontario through Free Trade within Canada

Act, 2025, this reform supports Ontario's
plan to strengthen interprovincial trade
and create a more flexible labour market.

For the legal profession, this represents a shift away from a patchwork of fees and examinations that have long restricted mobility. It presents lawyers with the opportunity to practice in Ontario with far fewer obstacles. The natural next step will be for other provinces and their law societies to adopt

similar measures, ensuring that this reform extends across Canada.

The Honourable retired Justice A. Ingram highlighted the need for greater mobility within the legal profession by recalling his time practicing in Nunavut. He described how charter planes were organized from Ottawa to Nunavut due to the shortage of legal representation. This experience, he noted, provided him with more valuable legal exposure in a short period than he might have gained in years of practice in Ontario, where lawyers and judges are far more numerous.

The current system is restrictive. While a few thousand dollars in fees may not present a challenge for senior partners with established practices, the same costs weigh far more heavily on young lawyers and sole practitioners. The truth is, these groups are often more willing, and more driven, to relocate or serve in underrepresented regions. In addition to

fees, lawyers must also complete further examinations. Although ambition may drive some to meet these requirements, the reality is that many young lawyers and sole practitioners are already stretched by the demands of earning their initial certifications and keeping their practices afloat, to find time to prepare for additional testing.

For provinces facing shortages of legal professionals, removing these barriers could prove immensely valuable. This development also aligns closely with s. 6 of the Charter, which guarantees every Canadian the mobility right to move to and pursue a livelihood in any province.

By reducing restrictions such as costs, and examinations, this new framework will make it easier for professionals to move where their skills are most needed. For employers, this means filling shortages more quickly and supporting major projects across the country. For workers, it creates new opportunities without the burden of extra fees and red tape. Ultimately, these reforms move Canada closer to a truly national labour market, where mobility is not restricted by provincial borders but guided by need and opportunity.

Here are a few regulatory updates that may affect your practice:

Anti-money laundering (AML): As of October 1, 2025, title insurers will be reporting entities under the Proceeds of Crime (Money Laundering) and Terrorist Financing Act, overseen by FINTRAC. Law Society of Ontario

Transparency changes: Convocation has approved more information in the Law Society directory — licensees can expect expanded public data in their profiles. <u>Iso.ca</u>

Complaints & reviews: Amendments to By-Laws 9 and 11 give the Commissioner expanded authority to refer complaints back for further action if not satisfied with how they were handled. Iso.ca

Governance reforms under debate:

Proposals to reduce the proportion of elected lawyers in Convocation have raised concerns about weakening professional self-regulation. <u>fola.ca</u>

CPD requirements remain unchanged:

Lawyers must continue to complete 12 CPD hours annually (3 professionalism, including 1 EDI, + 9 substantive). <u>Law</u> Society of Ontario+1

Civil Procedures – Partial Settlements & Disability Rules

As of June 16, 2025, Ontario's O. Reg. 50/25 introduced new requirements for **partial settlement agreements** under Rule 49.14. Settlements involving parties under disability now require judge approval and additional disclosures. mcleishorlando.com

Health Sector Innovation — Ontario's More Convenient Care Act (Bill 11, 2025)

This new legislation is aimed at making health care more connected and accessible. Key changes include:

 Expanded authority for nurse practitioners to complete mandatory blood testing forms (a role formerly restricted to physicians) <u>Business Law</u> <u>firm | Stikeman Elliott</u>

- New oversight and reporting obligations for health care staffing agencies Legislative Assembly of Ontario+1

3. Primary Care Act, 2025 (Bill 13)

Ontario has passed a framework law establishing the government's vision for **primary care**. The Act sets province-wide objectives for access, coordination, digital health integration, and accountability via annual reporting. <u>Legislative Assembly of Ontario+1</u>

4. Health Canada Regulatory Modernization

At the federal level, Health Canada has signalled a push toward regulatory modernization:

- A new "red tape reduction" initiative aims to streamline processes and adopt a more risk-based regulatory approach. <u>BLG</u>
- Changes to the Food and Drug Regulations (the "Agile Licensing" amendments) empower Health Canada to impose terms and conditions on drug and medical device approvals, expanding flexibility and faster pathways for certain products. Torys
- Mandatory transition to XML format for product monograph filings began July 18, 2025, affecting new drug and biologic submissions.

5. Regulation of Physician Assistants

On April 1, 2025, amendments to the Medicine Act came into force, making **physician assistants (PAs) a regulated health profession** under the College of Physicians & Surgeons of Ontario. Oha





Parental Leave and Lawyers: Challenges and Considerations

aking parental leave as a lawyer remains a complex and often difficult decision. Unlike larger corporate environments, many law firms-particularly small or mid-sized practices-struggle to absorb the workload when an associate or partner takes leave. This creates real challenges for both the lawyer and their colleagues.

Financial Impact

- For associates, reduced billings during leave can affect salary, bonuses, and future advancement.
- For partners, stepping back from clients may mean lost files or weakened relationships. Unlike salaried employees in other sectors, lawyers in private practice often bear a direct financial hit.

Practice Management

- Coverage during leave is uneven.
 In larger firms, files may be reassigned
 or temporarily covered by colleagues,
 but in smaller firms lawyers often
 have to manage their caseload up to
 the date of leave and then return to
 a backlog.
- Client relationships are at risk if transitions aren't managed carefully.
 Many clients prefer continuity and may resist reassignment.

Cultural Barriers

 There remains a stigma in some firms that taking leave signals a lack of commitment. Women are disproportionately affected, but male lawyers who seek leave also encounter raised eyebrows.

 Returning lawyers often face pressure to "make up" for lost time, which can contribute to burnout and attrition.

Policy Gaps

- Employment standards legislation provides minimum parental leave protections, but many lawyers are classified as independent contractors or partners and fall outside those frameworks.
- Law societies do not have standardized policies for supporting lawyers on leave, though some have practice management resources or financial assistance programs for sole practitioners.

What Can Help

- Firms can normalize parental leave by adopting written policies, planning coverage well in advance, and recognizing the long-term value of retaining talent.
- Professional associations can advocate for better structures and highlight model policies.
- Individual lawyers benefit from early planning: discussing coverage with clients, budgeting for reduced income, and setting boundaries for re-entry.

The Bottom Line

Parental leave is not just a personal issue-it is a systemic one. Without adequate supports, lawyers may leave practice altogether, which undermines retention, diversity, and continuity in the profession. Addressing this requires both cultural change and practical solutions at the firm and association level.



A Morning at the MLA Library

nother workday has just begun. It's going to be another busy one that involves a medley of court appearances, client meetings, drafting, and calls with opposing counsel. There is never a dull moment in the life of this young lawyer. Once at the courthouse, my first stop, as usual, is the Middlesex Law Association library. It's early and nobody else has arrived yet. Thankfully, I remember the door code.

There is a coffee machine here which dispenses free coffee. I take full advantage. The sound of the coffee brewing is the only thing that pierces the early morning library silence. I look around. There are so many books on the walls. My thoughts wander. If those books could only speak, they would surely tell so many stories about the lawyers of the Middlesex Law Association from years past.

The coffee pours. It is still too hot to sip, so I take the cup and make my way to the desk I sometimes like working at towards the rear of the library. The library is quite large so there is a considerable distance to travel. In fact, the MLA library might be one of the larger law association libraries in Ontario. I'm grateful to have access to such a resource. Since I work in a profession where knowledge of the law is a currency, I remind myself what a privilege it is to have access to a library with so many texts and access to online legal databases.

On my way to the workstation, I pass both privacy pods. The pods are a great place to enter when I have to partake in a phone or video call. The pods are sound proof, so they allow lawyers to engage in noisy tasks without disturbing others in the library.

As I walk past the shelves where all of the most valued texts are on display behind glass doors, I am surprised to find that one of the doors is partially open. That door was always locked when I passed it previously. {Ed: This "open" cabinet was pre-arranged} The old Middlesex Law Association minute books are on those shelves. As someone who has a passion for history, the opportunity to peek at these books is too great to resist. I take a few of the minute books and other ancient texts to my work station and begin reading.

I find myself reading what appears to be the original first MLA minute book. The pages bearing ink calligraphy are old and delicate so I take care when turning them. As I read, the history of the MLA begins to engulf me.

The MLA was incorporated 146 years ago, on October 27, 1879. The association had just 50 members then. The first President of the MLA was a man named William Ralph Meredith. He held that role for 14 years. He later was appointed Chief Justice of Ontario and was knighted by Queen Victoria. He also helped to form the London Law School.

I learn that there have been many other noteworthy members of the MLA. Perhaps the most unconventional career of an MLA lawyer was that of George Moorehead. He was called to the bar in 1885, then left London to act on stage in New York and elsewhere in the USA. After

25 years of acting, he returned to London to practice as a lawyer.

Another noteworthy former member of the MLA is Mayer Lerner, who began practicing here in London in 1929. He was the second Jewish lawyer to regularly practice in London, after Harold S. Chaplin. The fact that he was one of the only Jewish lawyers in the city did not hold Mayer back, as he went on to become a President of the MLA and a founding member of the Lerner and Lerner firm. The MLA lounge is named after him.

Another notable member of the MLA was Edward H. Braund, whose legal career from about the 1920's, onwards was conducted from a wheelchair. There would have been many navigation challenges for Mr. Braund in this early era as there were few accessibility accommodations in those days.

In 1940, MLA member John Campbell Elliot was raised to the Senate. When he passed away, Prime Minister King described him as "one of the most loyal and capable of men."

The MLA has a long history with the military. Many members of the MLA went to the front during both World Wars. Many joined the Royal Canadian Airforce and the Royal Canadian Navy during the Second World War. Notably, in 1946, Oliver W. (Pat) Durdin became the acting chief prosecutor in the Canadian Warcrime Trials in Germany. Both John D. Harrison and his partner E.C. (Ned) Elwood joined the fray as gunners in 1939. H.W. (Bill) Hockin was captain of the Essex Scottish Regiment when he was captured and made a prisoner of war.

In this way, the lawyers of London have guarded the civil liberty not just in the Ontario courts, but also overseas facing actual bullets on various battle fields. Many made the ultimate sacrifice to preserve that civil liberty when fighting overseas.

In 1945, Evelyn Harrison, Vivian Weekes, and Beth Underhill were the only female lawyers practicing in London. At that time there were seventy MLA members. My, how times have changed. It would not come as a surprise if someone told me that there are now more female members than male members in the MLA.

In 1951, MLA member J. Gordon Gillanders became the youngest person to be appointed as a judge for the Court of Appeal for Ontario. Arthur M. Lebel was another MLA member from that era who became a judge at the Court of Appeal for Ontario. Judge Lebel was apparently a very practical man.

This was demonstrated when he refused to enter, as a trial exhibit, a cantaloupe which had been used to demonstrate how a face-stabbing could have occurred accidentally.

Over the years, there has been extensive representation of MLA members on the municipal, provincial and federal political stages. In 1961, MLA member John Robarts became the Premier of Ontario.

By 1969, the number of lawyers practicing in London and Middlesex County had grown to 198. At that time the main courthouse was still the old Middlesex County Court building that is located on Ridout Street, in London.

The current, much larger, courthouse was not constructed until 1974.

Perhaps it gave the MLA room to grow as the number of MLA members has more than quadrupled since 1969.

Oh no, I must have been carried away and lost track of the time! That peek at the minute books turned into a full history lesson. I'll have to drink my cold coffee quickly and hurry up to courtroom number one so that I'm not late to Justice Sigurdson's youth criminal court.

I guess I'll have to wait to learn more about the Middlesex Law Association for now. What a privilege it is to be a member of a law association with such a proud history.
